This is a replacement fund update. It replaces the previous fund update for the quarter ending 30 June 2026, first made publicly available on 29 July 2026. This replacement updates the explanatory note in the "What fees are investors charged?" section regarding the variance between the total fund charges and the estimate disclosed in the PDS.

What is the purpose of this update?

This document tells you how the InvestNow Macquarie NZ Fixed Interest Fund has performed and what fees were charged. The document will help you to compare the fund with other funds. FundRock NZ Limited prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

Description of this fund

Objective: aims to provide a gross return above the return of the Bloomberg NZBond Composite 0+ Yr Index on a rolling three-year basis.

Strategy: provides exposure to an actively managed portfolio of fixed interest securities. It is a medium risk investment product, focusing predominantly on government bonds and corporate securities in the New Zealand market. Environmental, Social and Governance characteristics are integrated into the investment process where applicable.

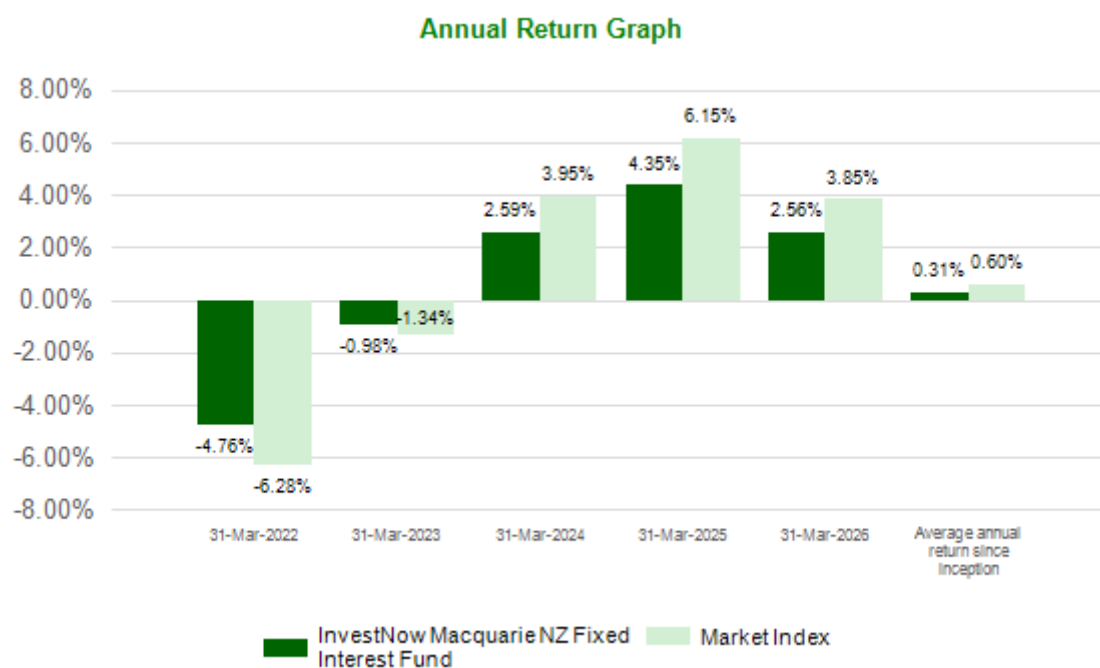

How has the fund performed?

What fees are investors charged?

Investors in the InvestNow Macquarie NZ Fixed Interest Fund are charged fund charges. In the year to 31 March 2026 these were:

The total fund charges for the most recent financial year differ from the estimate disclosed in the PDS primarily because of administration expenses incurred in operating the fund, including registry costs and audit fee allocations, and a reduction in the underlying fund's FUM. The PDS will be updated to reflect the revised estimate of total fund charges.

Investors may also be charged individual action fees for specific actions or decisions (for example, for withdrawing from or switching funds). Example of how this applies to an investor

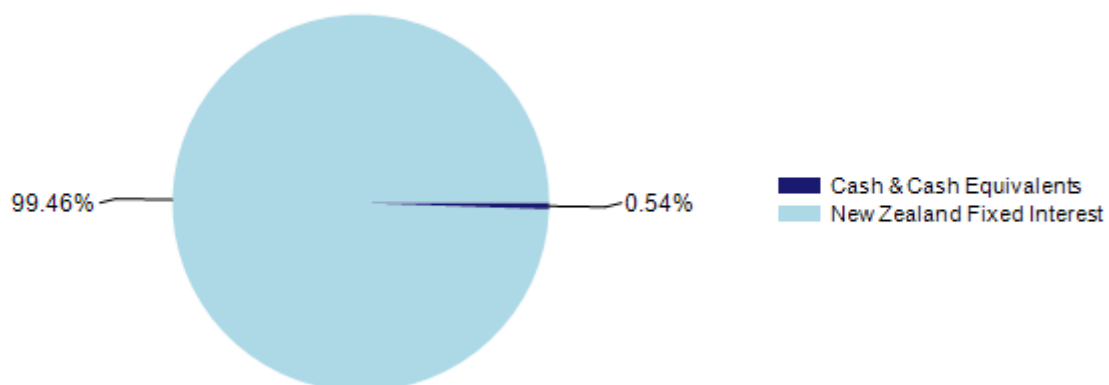
Small differences in fees and charges can have a big impact on your investment over the long term.

Anthony had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Anthony received a return after fund charges were deducted of \$517 (that is 5.17% of his initial \$10,000). This gives Anthony a total return after tax of \$371 for the period.

What does the fund invest in?
