What is the purpose of this update?

This document tells you how the Kernel Global ESG Fund has performed and what fees were charged. The document will help you to compare the fund with other funds. Kernel Wealth Limited prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

Description of this fund

The Kernel Global ESG Fund's investment objective is to provide a return (before tax, fees and expenses) that closely matches the return on the S&P World PAB ESG Ex-Non-Pharma Animal Testing (NZD) Index.

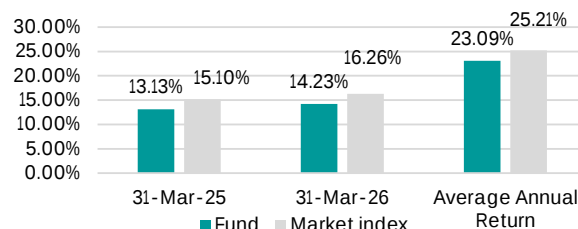
How has the fund performed?

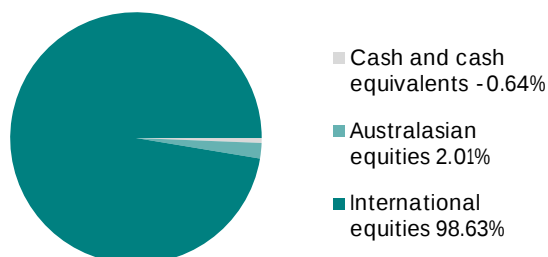
Investors are not charged individual action fees for specific actions or decisions (for example, for withdrawing from funds). All fees are inclusive of GST.

Example of how this applies to an investor

Emma had \$10,000 in the fund on 1 July 2025 and did not make any further contributions. On 30 June 2026, Emma received a return after fund charges were deducted of \$3,035 (that is 30.35% of her initial \$10,000). This gives Emma a total return after tax of \$2,865 for the period.
