What is the purpose of this update?

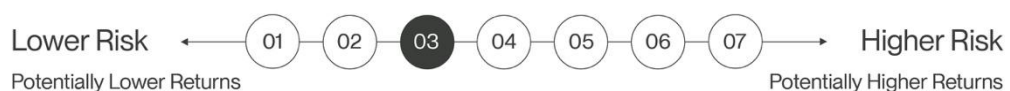
Description of this Fund

The Fund is an ethical portfolio with a higher exposure to income assets and a lower exposure to growth assets. This Fund's value is unlikely to fluctuate as much as the other Pathfinder KiwiSaver Funds.

What are the risks of investing?

Risk indicator for the Pathfinder KiwiSaver Conservative Fund:





The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the fund's assets goes up and down. A higher risk generally means higher potential returns over time, but more ups and downs along the way.

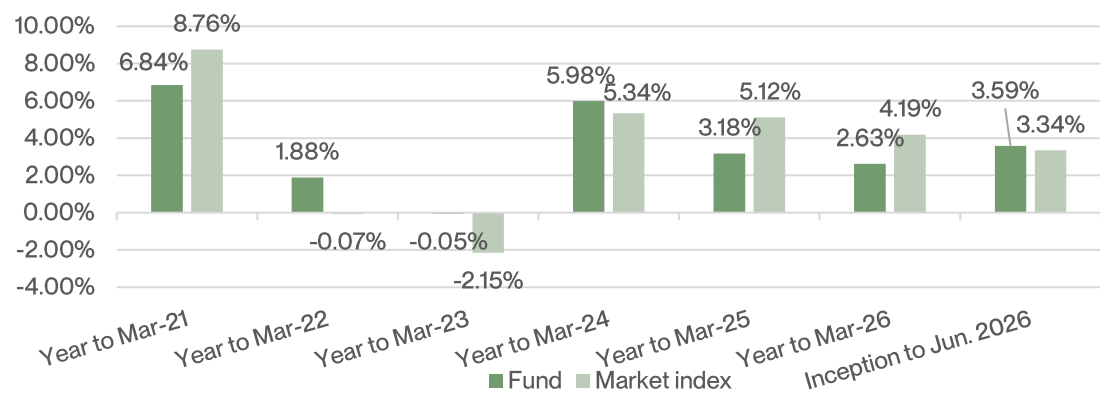

This shows the return after fund charges and tax for each year ending 31 March since the fund started. The last bar shows the average annual return since the fund started, up to 30 June 2026.

What fees are investors charged?

Investors in the Pathfinder KiwiSaver Conservative Fund are charged fund charges. In the year to 31 March 2026 these were:

** Other management and administration charges comprise fees paid by the Fund for its investment in the related funds, Pathfinder Green Bond Fund, and the Pathfinder Wholesale Fixed Income Fund (which, replaced the Alvarium Sustainable Income Fund from July 2025)..

*** Member fees are not applicable for members under 18 years old or members whose account balance is below \$5,000.

Performance fees and individual action fees: There are no performance fees or individual action fees.

Example of how this applies to an investor

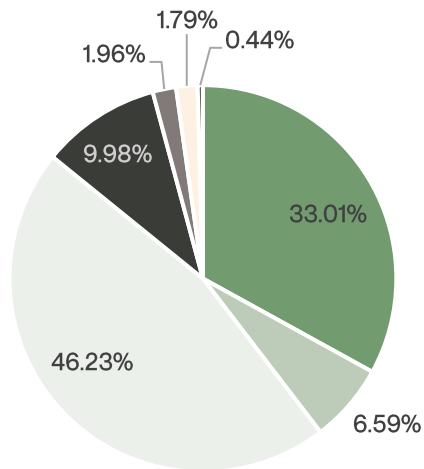
Tara had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Tara received a return after fund charges were deducted of \$411 (that is 4.11% of her initial \$10,000). Tara also paid \$27 in other charges. This gives Tara a total return after fees, charges, and tax of \$319 for the year.



What does the fund invest in?

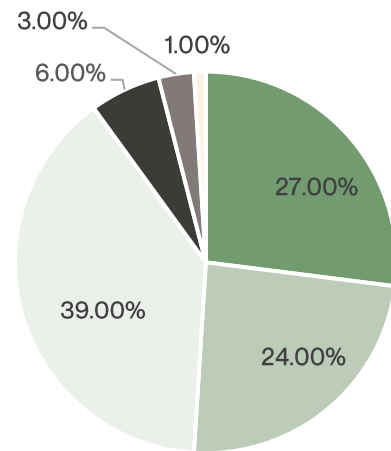
This shows the type of assets that the fund invests in.

The top 10 investments make up 21.00% of the net asset value of the fund.

Currency hedging: Changes in the value of the NZ dollar relative to other currencies can have a big impact on your investment over the long term. The target currency hedging is 50% of non-NZD equity exposure and 100% of non-NZD fixed interest exposure (actual hedging level at 30 June 2026 was 90.76% of the foreign currency exposure (this will change over time)). Total unhedged foreign exposure is 5.30% of the net asset value at 30 June 2026 (this will change over time).

Notes:

1. The market index changed from 1 May 2026 from the Morningstar® New Zealand Target Allocation Index: Conservative Multisector for New Zealand (100% of non-NZD Fixed Interest hedged to NZD) to the Morningstar® New Zealand Conservative Target Allocation Plus (100% of non-NZD Fixed Interest, and 50% of international equities hedged to NZD) for a more aligned currency hedging policy on international equities. The benchmark index is on a net return ('NR') basis, that is, including dividends and net of withholding tax for relevant equity classes. Historical index returns are used to calculate market index performance prior to 1 May 2026, and current market index returns are used since then. 2. Actual Investment Mix - Other: Other assets are direct investments that are unlikely to be stock exchange listed. These can include investments known as 'impact investments', 'venture capital', 'private loans' and 'private equity'. This category also includes unlisted property, such as direct ownership in property or ownership of property companies that are not listed on a stock exchange. Some of the private loans are with entities related to Pathfinder. Currently, the Fund's exposure to these private loans is 0.44% of the net asset value.
