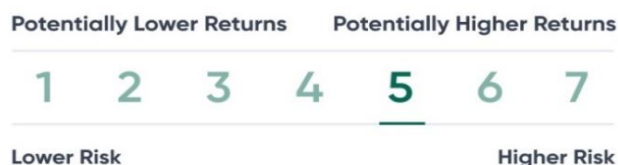
#### Description of this fund

The Kernel NZ 20 Fund invests in financial products listed on the NZX and is designed to track the S&P/NZX 20 Index.

#### What are the risks of investing?

Risk indicator for the Kernel NZ 20 Fund:

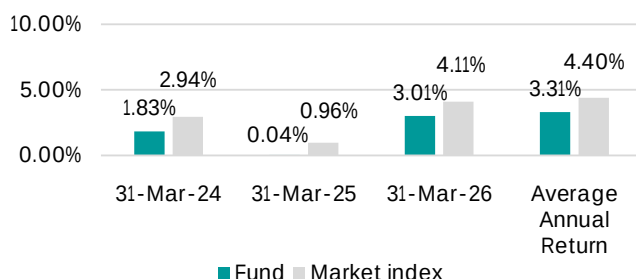

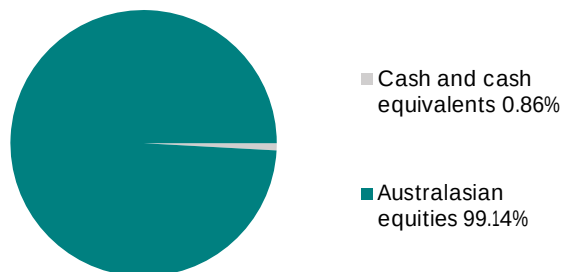
Investors are not charged individual action fees for specific actions or decisions (for example, for withdrawing from funds). All fees are inclusive of GST.

## Example of how this applies to an investor

Emma had \$10,000 in the fund on 1 July 2025 and did not make any further contributions. On 30 June 2026, Emma received a return after fund charges were deducted of \$780 (that is 7.8% of her initial \$10,000). This gives Emma a total return after tax of \$688 for the period.
