This is a replacement fund update. It replaces the previous fund update for the quarter ending 30 June 2026, first made publicly available on 29 July 2026. This replacement updates the explanatory note in the "What fees are investors charged?" section regarding the variance between the total fund charges and the estimate disclosed in the PDS.

What is the purpose of this update?

This document tells you how the InvestNow Mercer Responsible Balanced Fund has performed and what fees were charged. The document will help you to compare the fund with other funds. FundRock NZ Limited prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

Description of this fund

Objective: aims to achieve a rate of return (after fees) that exceeds CPI increases by at least 2.5% per annum after tax and 3.5% before tax over a minimum of eight years, and to outperform, over periods of one year or greater, the weighted average return of the market indices used to measure performance of the underlying funds/assets.

Strategy: provides exposure to a diversified portfolio with a slightly higher allocation to a mix of growth assets (e.g. shares and listed infrastructure) relative to a mix of income assets (e.g. cash and fixed interest). The fund is managed with reference to environmental, social and governance factors and has exposure to investment strategies targeting sustainability themes.

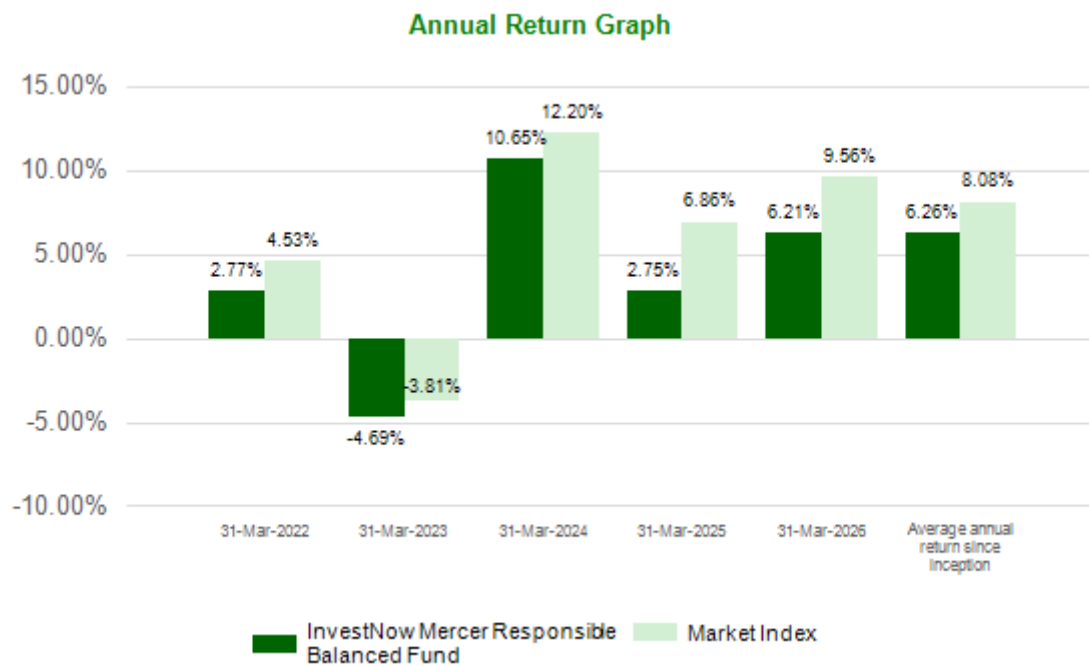

How has the fund performed?

What fees are investors charged?

Investors in the InvestNow Mercer Responsible Balanced Fund are charged fund charges. In the year to 31 March 2026 these were:

The total fund charges for the most recent financial year differ from the estimate disclosed in the PDS primarily because of administration expenses incurred in operating the fund, including registry costs and audit fee allocations, and a reduction in the underlying fund's FUM. The PDS will be updated to reflect the revised estimate of total fund charges.

Investors may also be charged individual action fees for specific actions or decisions (for example, for withdrawing from or switching funds). Example of how this applies to an investor

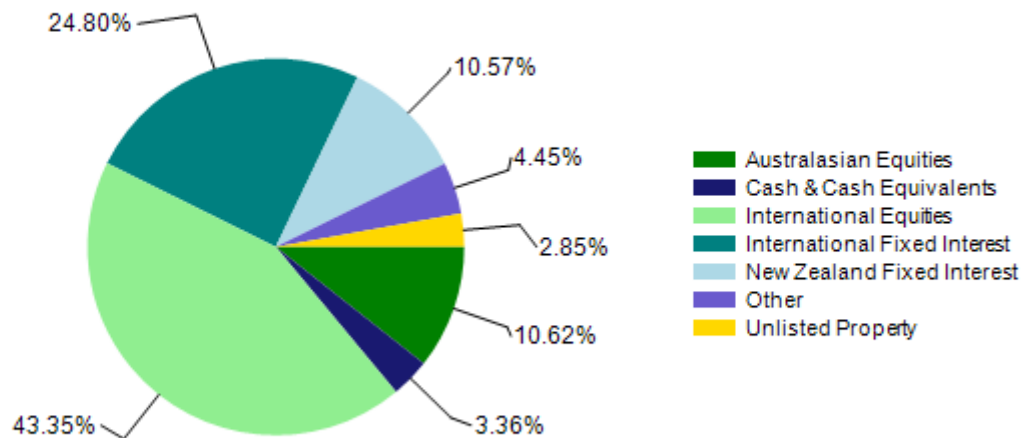
Small differences in fees and charges can have a big impact on your investment over the long term.

Anthony had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Anthony received a return after fund charges were deducted of \$1,089 (that is 10.89% of his initial \$10,000). This gives Anthony a total return after tax of \$1,002 for the period.

What does the fund invest in?

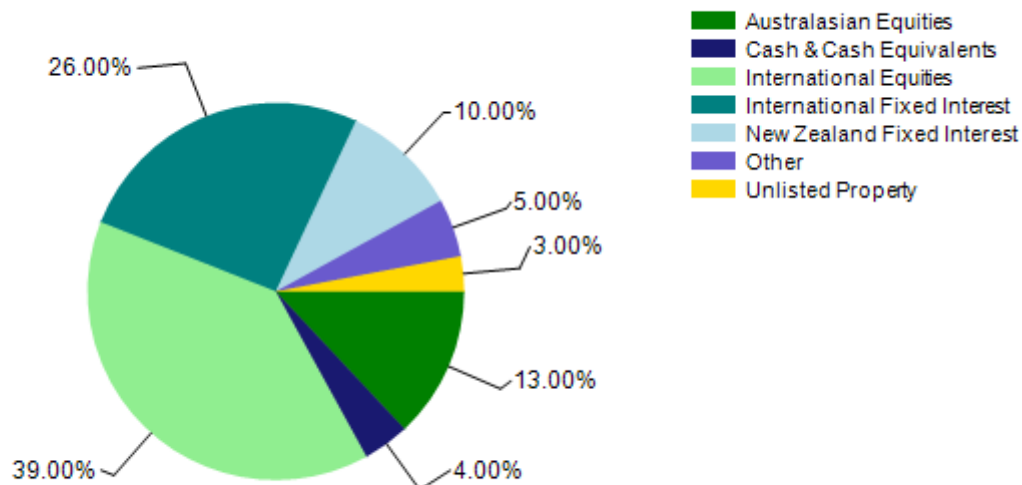
This shows the types of assets that the fund invests in.

Actual Investment Mix



The fund targets a position of exposure to foreign currency being 50% hedged back to the New Zealand dollar for international equities, although this may be actively managed between the range of 0% and 100%. For real estate investments and international fixed interest, the underlying fund targets 100% hedging of foreign currency exposure back to the New Zealand dollar.
