What is the purpose of this update?

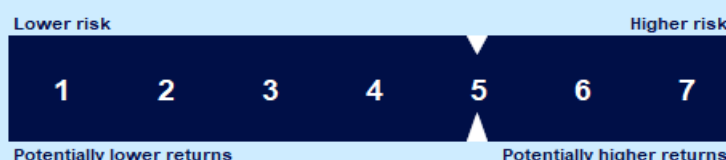
Description of this fund

The fund is a passively managed international shares portfolio that is designed to track the return of the MSCI All Country World ex Tobacco Index. Environmental, Social and Governance characteristics are integrated into the underlying investment managers' investment processes. The fund aims to provide a return that closely matches the return of the MSCI All Country World ex Tobacco Index with net dividends reinvested (50% hedged to NZD on an after-tax basis).

What are the risks of investing?

Risk indicator for the Mercer All Country Global Shares Index Fund:



The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the fund's assets goes up and down. A higher risk generally means higher potential returns over time, but more ups and downs along the way.

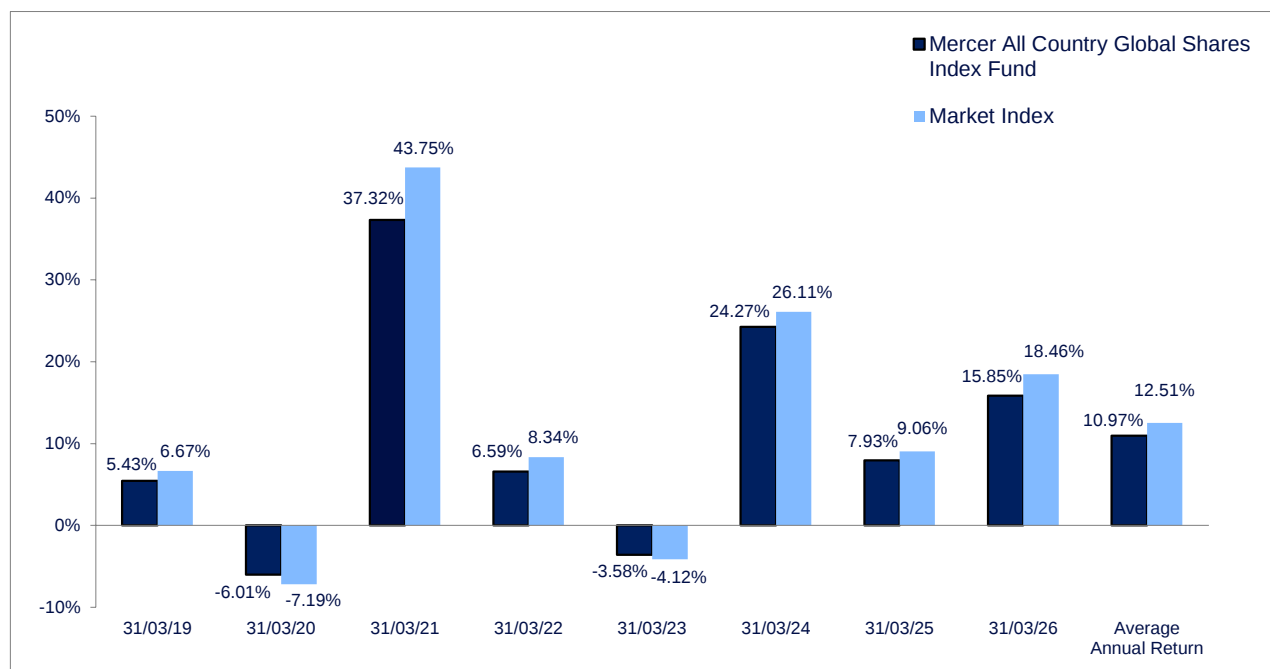

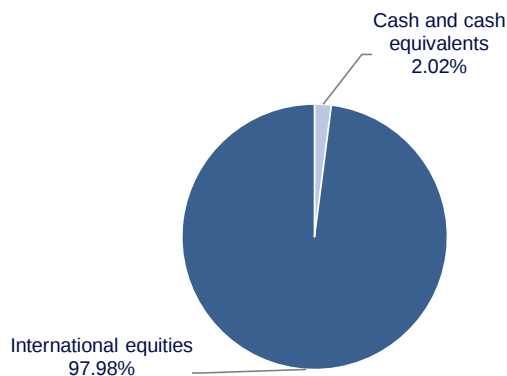
Example of how this applies to an investor

Ben had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Ben received a return after fund charges were deducted of \$2,564.00 (that is 25.64% of his initial \$10,000). Ben also paid \$0.00 in other charges. This gives Ben a total return after tax of \$2,564.00 for the year.

What does the fund invest in?

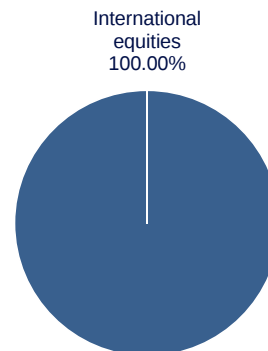
Actual investment mix⁴

Currency management

The fund targets a position of being 50% gross hedged to New Zealand dollars, with the hedges based on the currency weights of the underlying index. Currency hedges are normally rebalanced monthly but may be adjusted intra-month for significant cash flows. Hedging coverage, on a net of tax basis, for the fund's exposure to foreign currency as at 30 June 2026 was 49.32%.
