What is the purpose of this update?

This document tells you how the Mercer Core Hedged Global Shares Fund has performed and what fees were charged. The document will help you to compare the fund with other funds. Mercer (N.Z.) 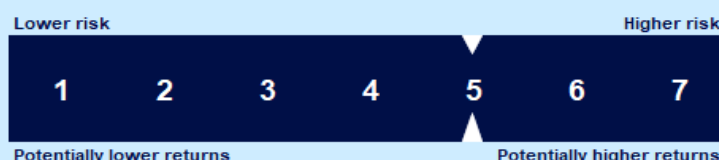
Description of this fund

The fund invests in shares listed on share markets predominately in developed economies and is fully hedged to the New Zealand dollar. The portfolio uses multiple managers and is diversified by region, manager and investment approaches. Environmental, Social and Governance characteristics are integrated into the underlying investment managers' investment processes. The fund aims to provide a Gross Return¹ above the return of the MSCI World Index with net dividends reinvested (100% hedged to the NZD on an after-tax basis) on a rolling three-year basis.

What are the risks of investing?

Risk indicator for the Mercer Core Hedged Global Shares Fund:



The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the fund's assets goes up and down. A higher risk generally means higher potential returns over time, but more ups and downs along the way.

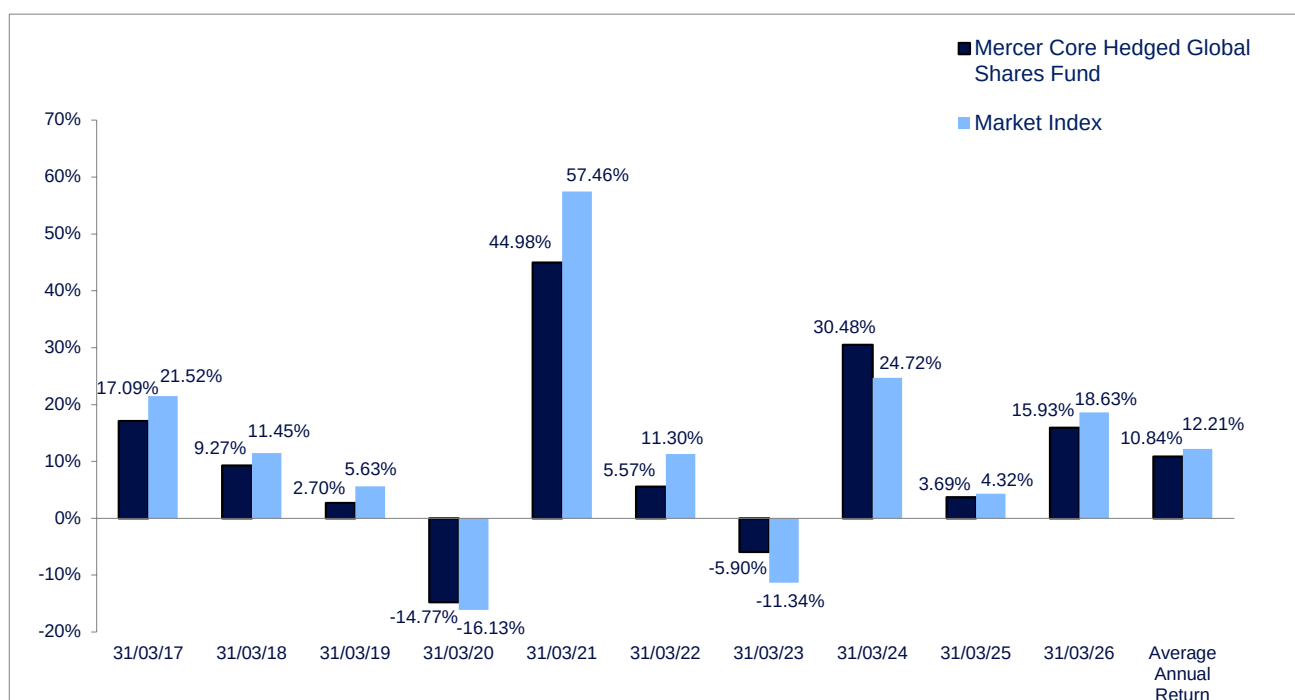

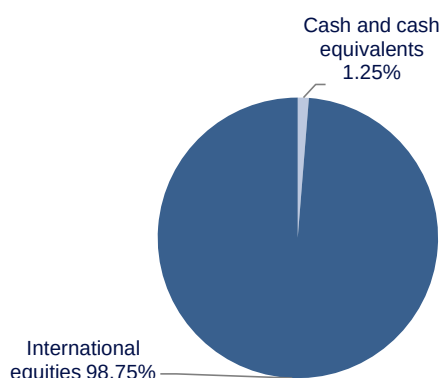
Example of how this applies to an investor

Ben had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Ben received a return after fund charges were deducted of \$1,974.00 (that is 19.74% of his initial \$10,000). Ben also paid \$0.00 in other charges. This gives Ben a total return after tax of \$1,974.00 for the year.

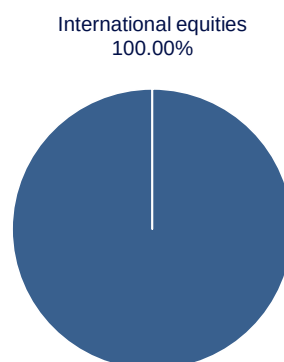
Actual investment mix⁵

Currency management

The fund targets a position of being 100% gross hedged to the New Zealand dollar with the hedges based on the currency weights of the underlying index. Currency hedges are normally rebalanced monthly but may be adjusted intra-month for significant cash flows. Hedging coverage, on a net of tax basis, for the fund's exposure to foreign currency as at 30 June 2026 was 98.17%.

1. Gross Return is the return before the deduction of tax, expenses and fees and assumes all income is reinvested.
2. These returns are for the periods ending 30 June 2026.
3. The bar graph shows fund returns after the deduction of fees and tax, however, the market index returns are shown before any fees or tax are deducted.
4. GST was charged at 15% on 10% of the management fee in accordance with the non-binding IRD agreement with the Financial Services Council of New Zealand Incorporated on behalf of the funds management industry up until 31 March 2026. From 1 April 2026 GST is not charged on management fees in accordance with Inland Revenue's Interpretation statement IS 25/05.
5. For the reporting of the types of assets under "Actual investment mix", foreign exchange hedging positions have been assigned to the asset class to which they relate.
6. The Top 10 investments have been calculated excluding operational cash and derivatives.
