What is the purpose of this update?

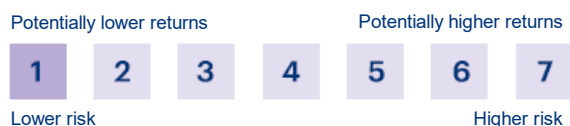
Description of this fund

The Cash Fund invests in a range of cash and cash equivalent investments. The Fund aims to achieve stable returns over the short term. It is suitable for investors who require an investment with very low volatility.

What are the risks of investing?

Risk indicator for the Cash Fund:



The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the fund's assets goes up and down. A higher risk generally means higher potential returns over time, but more ups and downs along the way.

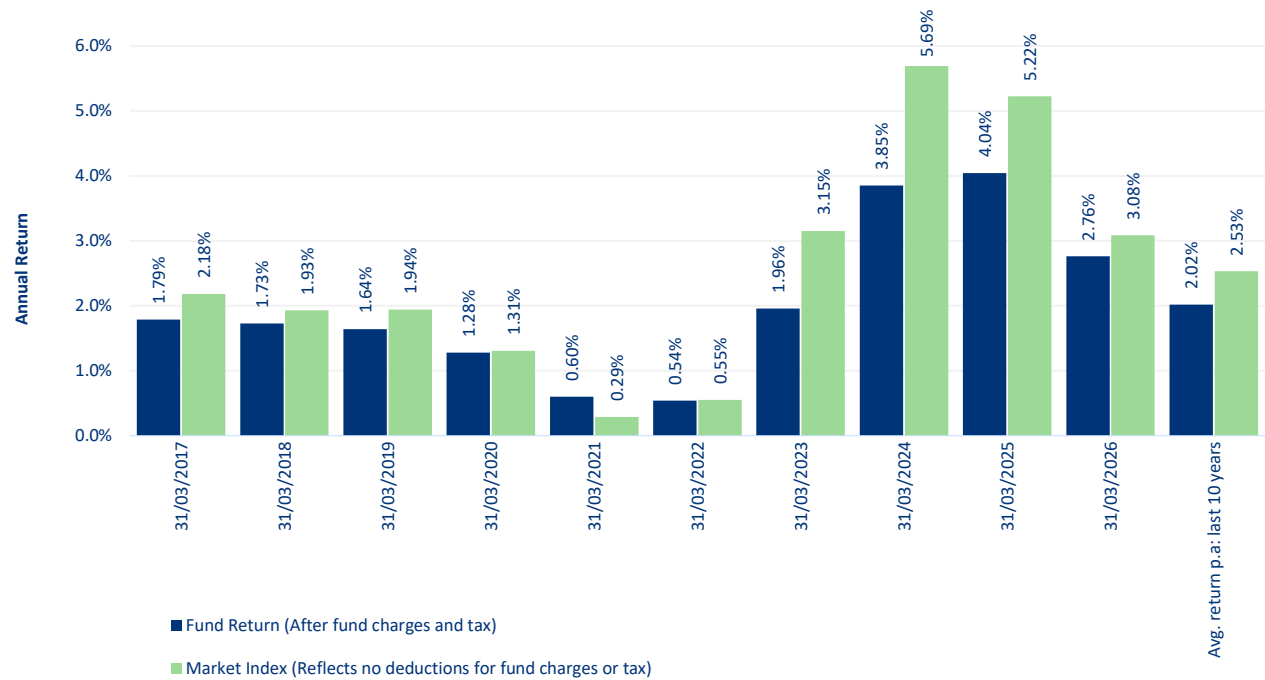

How has the fund performed?

Small differences in fees and charges can have a big impact on your investment over the long term.

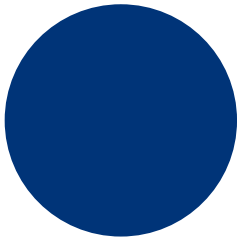
Example of how this applies to an investor

Sam had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Sam received a return, after fund charges were deducted, of \$252 (that is 2.52% of his initial \$10,000). Sam also paid \$0 in other charges. This gives Sam a total return after tax of \$252 for the year.

This shows the types of assets that the fund invests in.

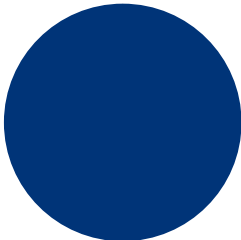
Actual investment mix
