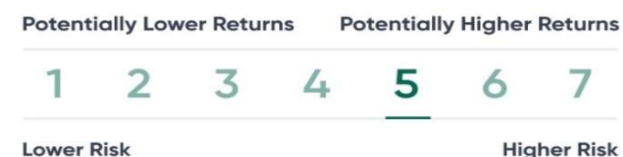
Description of this fund

The Kernel Emerging Markets Fund's investment objective is to provide a return (before tax, fees and expenses) that closely matches the return on the S&P Emerging BMI (NZD) Index.

What are the risks of investing?

Risk indicator for the Kernel Emerging Markets Fund:

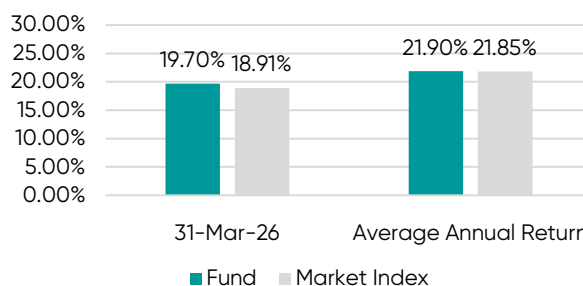

What fees are investors charged?

Investors in the Kernel Emerging Markets Fund are charged fund charges. In the year to 31 March 2026 these were:

Investors are not charged individual action fees for specific actions or decisions (for example, for withdrawing from funds). All fees are inclusive of GST. Small differences in fees and charges can have a big impact on your investment over the long term.

Example of how this applies to an investor

Emma had \$10,000 in the fund on 1 July 2025 and did not make any further contributions. On 30 June 2026, Emma received a return after fund charges were deducted of \$3,215 (that is 32.15% of her initial \$10,000). This gives Emma a total return after tax of \$3,048 for the period.
