What is the purpose of this update?

This document tells you how the Kernel US Bond Fund has performed and what fees were charged. The document will help you to compare the fund with other funds. Kernel Wealth Limited prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

Description of this fund

The Kernel US Bond Fund's investment objective is to provide a return (before tax, fees and expenses) that closely matches the return on the Bloomberg US Aggregate Bond Index Hedged NZD.

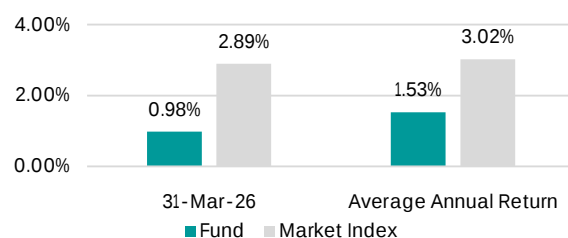
How has the fund performed?

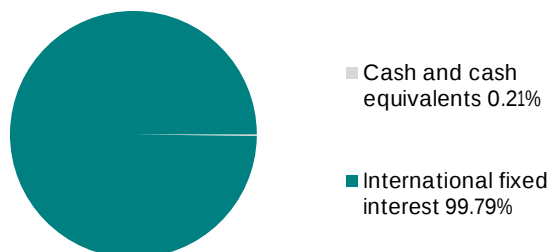
Investors are not charged individual action fees for specific actions or decisions (for example, for withdrawing from funds). All fees are inclusive of GST.

Example of how this applies to an investor

Emma had \$10,000 in the fund on 1 July 2025 and did not make any further contributions. On 30 June 2026, Emma received a return after fund charges were deducted of \$206 (that is 2.06% of her initial \$10,000). This gives Emma a total return after tax of \$59 for the period.
