### What is the purpose of this update?

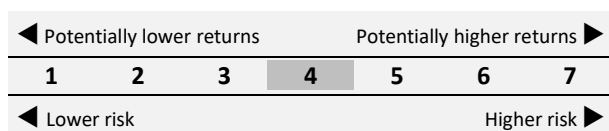
### Description of this fund

The Balanced Fund target asset allocations are 50% in growth assets and 50% in income assets. Its objective is to achieve positive real returns over the medium to long term through investment in a balanced mix of growth and income assets.

### What are the risks of investing?

Risk indicator for the Balanced Fund:



The risk indicator is rated from 1 (low) to 7 (high).

The rating reflects how much the value of the fund's assets goes up and down. A higher risk generally means higher potential returns over time, but more ups and downs along the way.

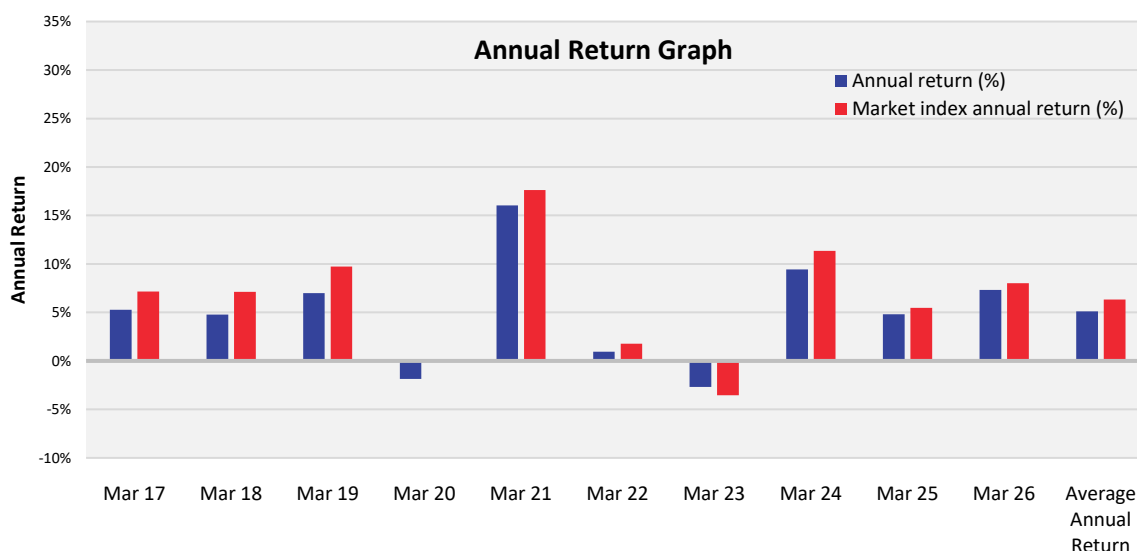

### How has the fund performed?

### Example of how this applies to an investor

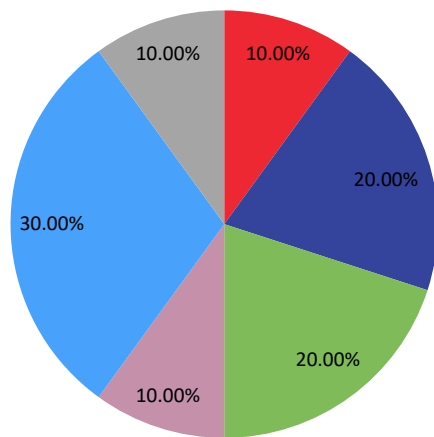
Small differences in fees and charges can have a big impact on your investment over the long term.

Ian had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year Ian received a return after charges and tax of \$731 (that is 7.31% of his initial \$10,000).

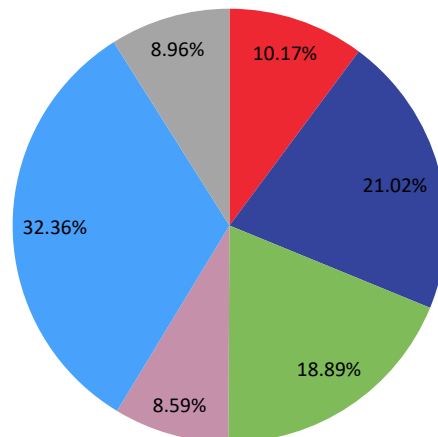
This shows the types of assets that the fund invests in.
