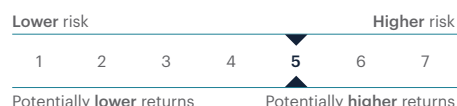
Description of this Fund

What are the risks of investing?

Risk indicator for the Trans Tasman Equity Trust:



The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the fund's assets goes up and down. A higher risk generally means higher potential returns over time, but more ups and downs along the way.

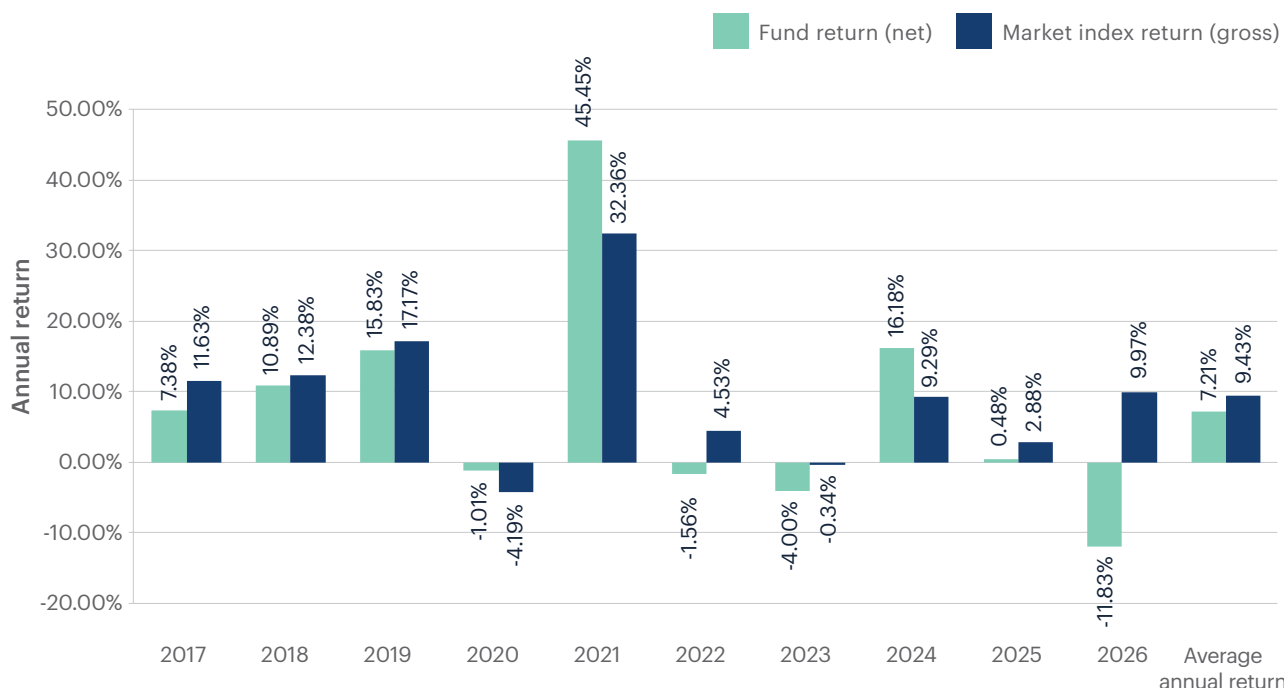
How has the fund performed?

Annual return graph



This shows the return after fund charges and tax for each of the last 10 years ending 31 March. The last bar shows the average annual return for the last 10 years, up to 30 June 2026.

What fees are investors charged?

Investors in the Trans Tasman Equity Trust are charged fund charges. In the year to 31 March 2026 these were:

Small differences in fees and charges can have a big impact on your investment over the long term. GST has been included in the Manager's basic fee and has been added to the other management and administration charges where applicable.



Example of how this applies to an investor

Sarah had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Sarah incurred a loss after fund charges were deducted of -\$1,190 (that is -11.90% of her initial \$10,000). Sarah did not pay other charges. This gives Sarah a total loss after tax of -\$1,190 for the year.

Actual investment mix

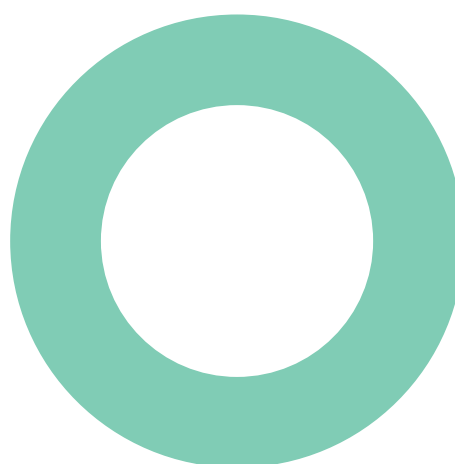
This shows the types of assets that the fund invests in.

Currency hedging

The benchmark currency hedge ratio for Australian equities is 70% hedged into NZD. At quarter end the fund was 70.9% hedged into NZD.
