Description of this fund

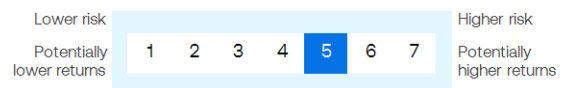
The Select International Share Fund invests mainly in international equities with a focus on environmental, social and governance (ESG) considerations. Investments may include equities in companies that are listed on a recognised stock exchange, and cash and cash equivalents.

The Select International Share Fund aims to achieve a return (after the fund charge and before tax) that over the long-term outperforms the relevant market index.

What are the risks of investing?

Risk indicator for the Select International Share Fund:



The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the fund's assets goes up and down. A higher risk generally means higher potential returns over time, but more ups and downs along the way.

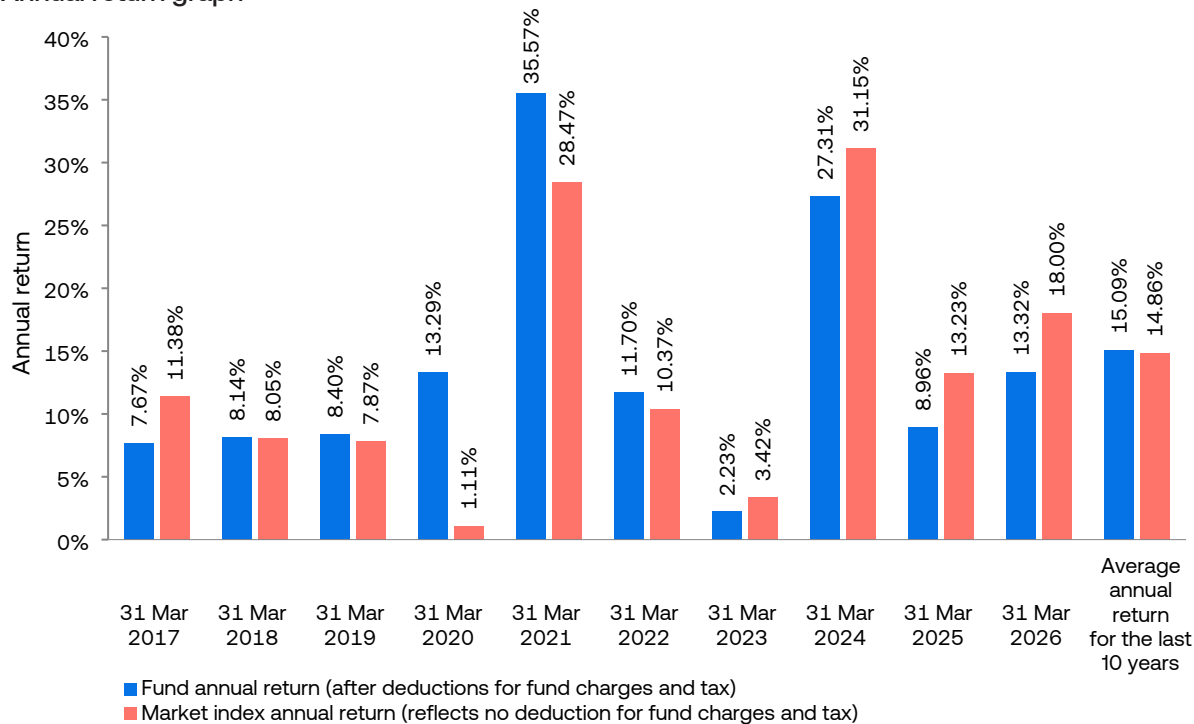
How has the fund performed?

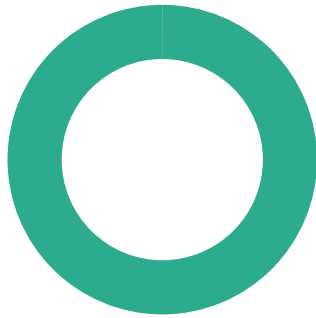
Example of how this applies to an investor

Sarah had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Sarah received a return after fund charges were deducted of \$2,481 (that is 24.81% of her initial \$10,000). Sarah did not pay any other charges. This gives Sarah a total return after tax of \$2,481 for the year.

Actual investment mix²

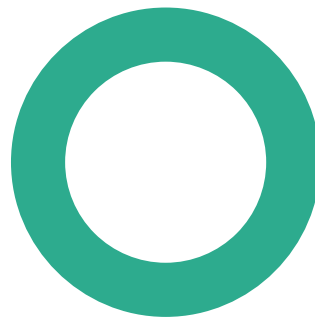
This shows the types of assets that the fund invests in.
