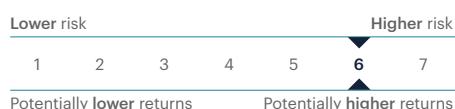

Risk indicator for the International Growth Fund:



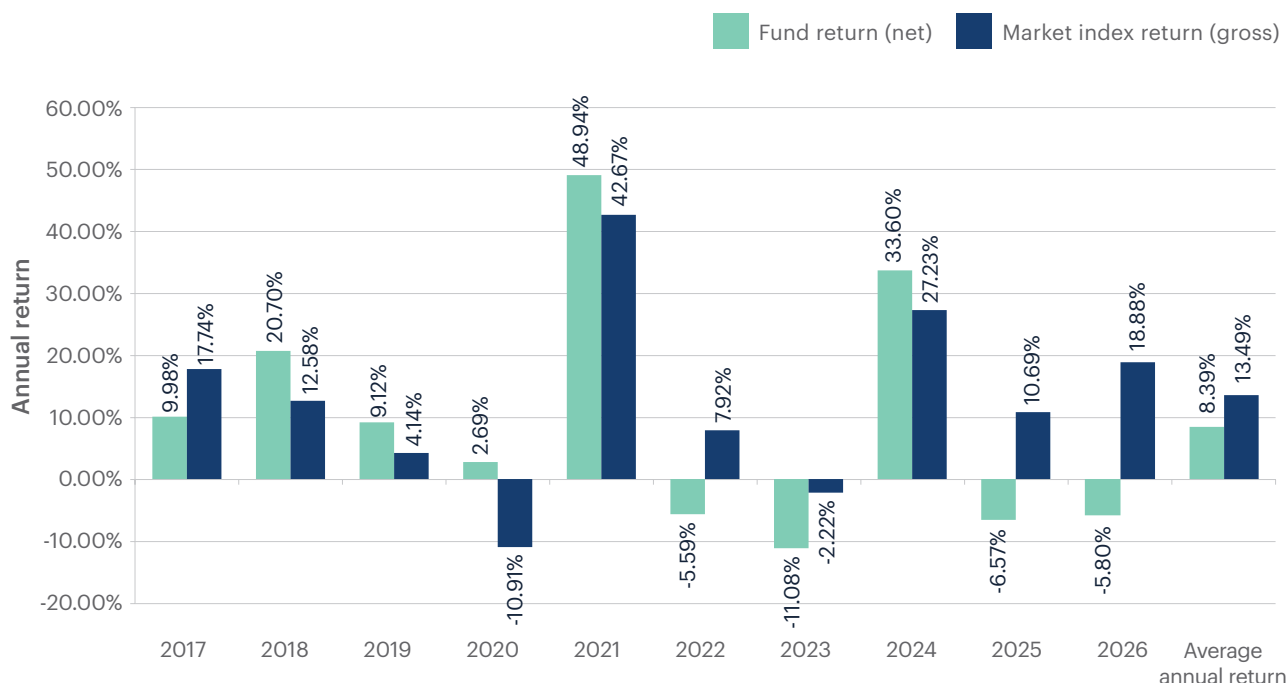

What fees are investors charged?

Investors in the International Growth Fund are charged fund charges. In the year to 31 March 2026 these were:

GST has been included in the Manager's basic fee and has been added to the Other management and administration charges where applicable.



Example of how this applies to an investor

Katie had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Katie incurred a loss after fund charges were deducted of -\$890 (that is -8.90% of her initial \$10,000). Katie did not pay other charges. This gives Katie a total loss after tax of -\$890 for the year.

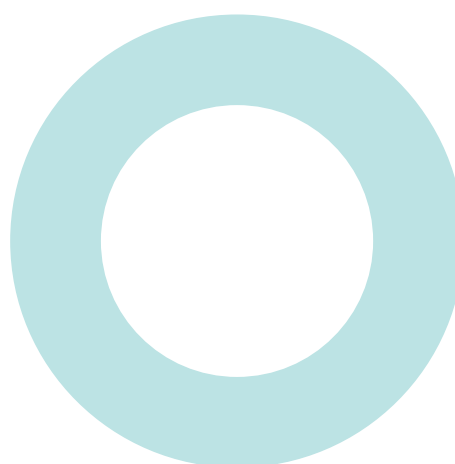
This shows the types of assets that the fund invests in.

Currency hedging
