What is the purpose of this update?

This document tells you how the Kernel S&P 500 (Unhedged) Fund has performed and what fees were charged. The document will help you to compare the fund with other funds. The Kernel S&P 500 (Unhedged) Fund's investment objective is to provide a return (before tax, fees and expenses) that closely matches the return on the S&P 500 (NZD) Index.

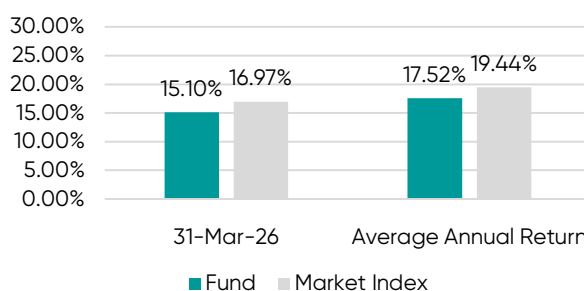
How has the fund performed?

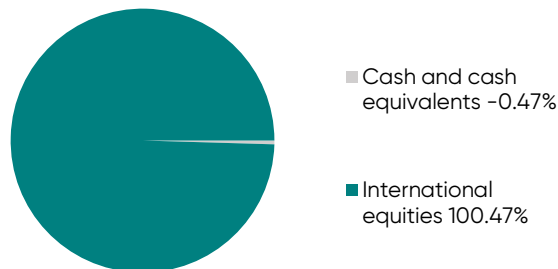

Notes

¹ Market index returns (as well as actual returns) have been used to complete the risk indicator, as the fund has not been in existence for 5 years. As a result, the risk indicator may provide a less reliable indicator of the potential future volatility of the fund. The risk indicator for the fund uses 3 year(s) 5 month(s) of market index returns.

Example of how this applies to an investor

Emma had \$10,000 in the fund on 1 July 2025 and did not make any further contributions. On 30 June 2026, Emma received a return after fund charges were deducted of \$3,020 (that is 30.2% of her initial \$10,000). This gives Emma a total return after tax of \$2,851 for the period.
